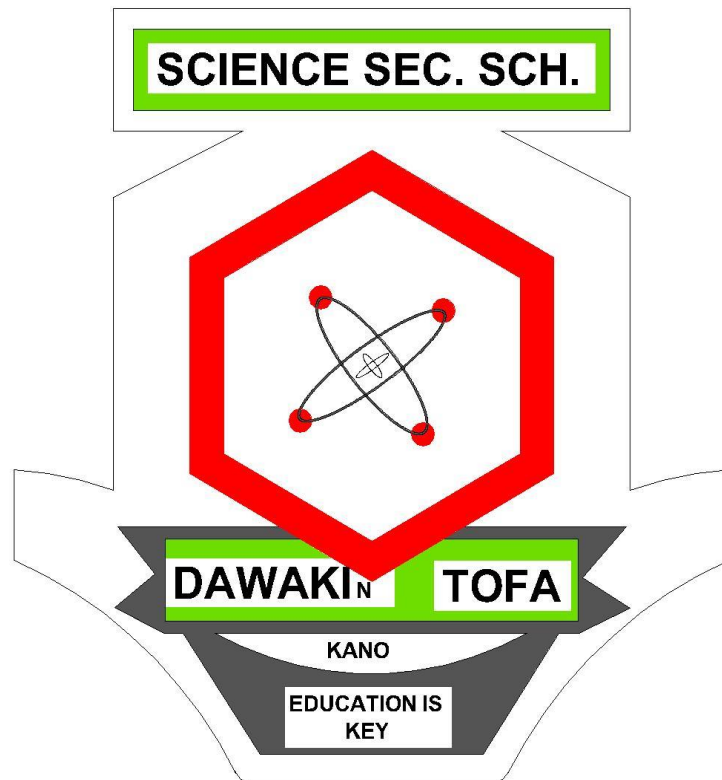

A. ARTICLE VI: EXECUTIVE COUNCIL

The executive council shall have an executive council of six members which shall consist of the following offices:-

1. The president
 2. Vice President
 3. Secretary General
 4. Financial Secretary
 5. Organizing Secretary
 6. Public Relation Officer (PRO)
- ❖ All Duties of the treasurer will be assigned to financial secretary
 - ❖ All duties of welfare and social director will be assigned to organizing secretary
 - ❖ All duties of assistant secretary general remain with the secretary general
 - ❖ All duties of PRO II remained with only one PRO

B. ARTICLE VI: SECTION 1
SUB-SECTION V AND VII
DUSTIES OF THE PRESIDENT

The president shall:-

V. Together with the financial secretary approved and sign for withdrawal of any amount from the associations account.

VII. Determine the presentation of certificate to any executive officer at the expiration of their tenure so as to ensure punctuality of the executive members.

V. Present a gift to any active member at his wedding ceremony and ensure proper representation of members at the event

DUTIES OF THE FINANCIAL SECRETARY –ADDED

vi. Be the chairman of fund raising committee whenever the needs arise.

ARTICLE X:

SECTION 3, ELIGIBILITY OF CANDIDATE TO CONTEST SUB-

SECTION III, IV, VI, AND VII

iii. Candidate contesting for the office of the president must be a graduate of any recognized university, polytechnic or any other tertiary institutions.

iv. Candidate for the office of secretary general, financial secretary and organizing secretary must to be a graduate of any tertiary institutions and be domiciled of Kano City.

V. Candidate aspiring for the office of the president and secretary general must have a cognate experience of leadership in this association or any other.

SUB-SECTION V AND VI: are hereby removed

D. ARTICLE VIII: FINANCE
SECTION 4, 5, 8, 9 AND 10

4. The association shall keep and maintain a corporate and indigenous bank account with the signatories comprising of the president and financial secretary for any withdrawal. And the association's cheque book shall be kept in custody of the financial secretary.

5. There must be an impressed amount of not more than three thousand (N3, 000) Naira only to be kept by the financial secretary at any instance as Maintained in article VI, subsection

VII.

8. The bank transaction schedule should be used by the financial secretary to record all deposits and withdrawal from the bank.

9. At-least 30 %(thirty percent) of the associations money should be left for the incoming Exco during handing over.

10. All members should pay a dues of nothing less than two thousand (N2,000) Naira only annually into the associations account which will be made available to all members. And president will receive the alert of each payment by the member and tick on the list against such payer
